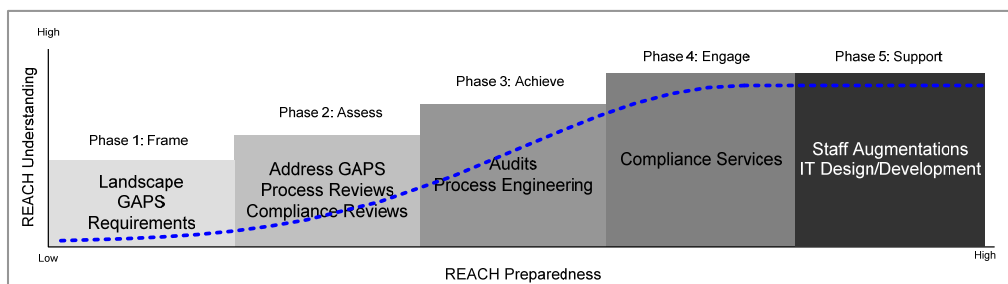
REACH LEGISLATION

REACH (**R**egistration, **E**valuation, **A**uthorization and **R**estriction of **C**hemical substances) is a European Community Regulation on chemicals and their safe use and is considered the most ambitious chemical legislation that has been enacted anywhere in the world. The new law entered into force on 1 June 2007 and requires the registration over a period of 11 years of some 30,000 chemical substances that are in use today. The law transfers responsibility for the generation of safety data about chemical substances from regulatory authorities to industry.
