Customized Audit System (CAS 5.0)

CAS 5.0 identifies fraud, waste and abuse within medical and pharmacy claims on a pre-pay and post-pay basis. This Windows-based, web-enabled system is designed to analyze 100 percent of your claims to identify inappropriate payments using parameter-driven rules. You decide what edit system you would like to include, and CGI customizes the system to your specific reimbursement methodologies. CAS 5.0 is licensed and utilized internally by CGI for outsourced claims auditing and fraud investigations work.

The Business Intelligence Module (BIM) allows auditors/investigators to analyze relationships and highlight exceptions to large volumes of data, while creating individual views for analysis and charts and graphs to display the results. Data can be exported into a wide variety of formats, including Excel, for additional analysis. This module allows our clients to mine, not only the raw claims data that has been imported for editing, but also the audit outcomes to identify new or emerging opportunities.
