REACH LEGISLATION

REACH (**R**egistration, **E**valuation, **A**uthorization and **R**estriction of **C**hemical substances) is a European Community Regulation on chemicals and their safe use and is considered the most ambitious chemical legislation that's been enacted anywhere in the world. The new law entered into force on 1 June 2007 and requires the registration over a period of 11 years of some 30,000 chemical substances that are in use today. The law transfers responsibility for the generation of safety data about chemical substances from regulatory authorities to industry.

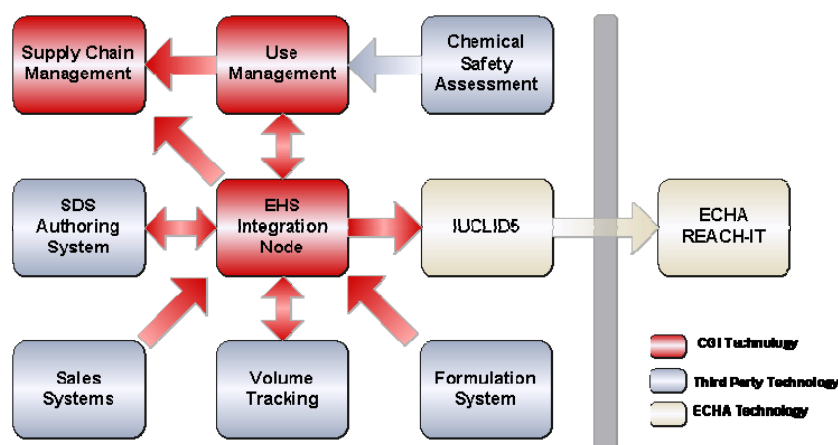
Streamlined reporting - Our software does the work for you by interfacing with your SDS authoring system to identify REACH products. The toolset maintains and reports REACH data for every required product.

You get direct access to the right information without the risks of additional data entry.

Flexibility - Because your customers have different needs, **REACHMate** offers you flexibility in how you publish exposure scenarios on your Safety Data Sheets (SDSs) when you ship chemicals or substances. Our toolset captures this information at both the substance and product level.

Easily updatable - Recognizing that REACH regulations are likely to continue to evolve, the toolset is designed to accommodate easy and quick interface updates without requiring software releases.

REACHMate is a comprehensive and flexible solution that integrates with your third party systems.



REACHMate consists of the following components:

EHS Integration Node

At the operational center of REACHMate is the **EHS Integration Node**, which supports the exchange of data to and from each integrated system. A Web-based front end provides administrative capabilities to monitor interfaces and assist with building additional interfaces beyond the core set provided. The ability to maintain interfaces within the Integration Node allows our toolset to flexibly respond to changes in third-party systems, such as IUCLID5, without software releases.

Use Management

Use Management manages how you document the use of regulated chemicals and their exposure scenarios for safe usage. This web-based software provides an easy resource both for registering new substances and for communicating appropriate information on the eSDS.

Supply Chain Management

Supply Chain Management manages and communicates REACH registration data across your supply chain. Combining a simple and customizable user interface with a robust template and rules-based communication engine, this solution allows you to quickly provide registration information to your customers and coordinate responses to your suppliers in order to assure compliance with REACH.

Interfaces

You can integrate third-party systems with REACHMate to manage the access and/or transfer of data among systems. Interfaces include: IUCLID5, Formulation systems, Authoring systems Interface, Volume tracking systems Interface.
