Taxi cabs

To reach the taxi stand exit Baggage Claim on the lower level and cross the first road to the commercial roadway. The taxis will be on the left.

Shuttle service

Starr Transportation shuttle is the official airport shuttle service of TUC and PHX. The cost per passenger from TUC to the JW Marriott Tucson Starr Pass is approximately \$45.00 USD one way. The cost per passenger from PHX to the JW Marriott Tucson Starr Pass is approximately \$275.00 one way. Reservations can be made online or by phone at (520) 544-7895. There are various other transportation services available online.

Rental cars

Tucson offers seven car rental companies that have counters and cars in the Rental Car facility. The Rental Car facility is at the east exit of the terminal. From Baggage Claim, use the link moving sidewalk from baggage carousel 7. From the ticketing level, walk down the ramp east of the United Airlines ticket counter.

The Rental Car Center at PHX accommodates all airport rental car companies, their rental counters and vehicles. If you are planning to rent a car from PHX, be sure to make a reservation. Vehicles are limited for walkup customers. The Rental Car Center is located within its own building at 1805 E. Sky Harbor Circle South (between 16th

Street and 24th Street, south of Buckeye Road). You can ride the common Rental Car Shuttle which can be accessed at the curb on baggage claim levels of each terminal.
