
# Data has become a key business asset and effective management of it is vital

### **CGI LMT**

Our CGI Landscape Management Tool (LMT) is a highly customisable, purpose built tool which overcomes the limitations of configuration and data constraints within the SAP landscape. Its core modules can be configured to assist with all stages of data management, from construct design through to operational management, as shown in the diagram below.





#### CGI LMT Case Study

A European Car Manufacturer approached CGI when facing the complicated process of identifying and managing customer identifiable data in their primary SAP systems due to incoming GDPR legislation.

The situation was complex due to multiple deployments of SAP and over 20 years of data collected. No formal process had been implemented for the removal, archive or destruction of historical data and customer records were held in multiple locations.

CGI utilised the powerful toolset available through LMT to meet the requirements. Firstly, to identify where sensitive data was held within the systems, then to anonymise the data so that it could not be used to identify individual customers.

Finally, we implemented ongoing controls to continuously anonymise data against a set of metrics and ultimately delete the data automatically against trigger events, such as client request or engagement inactivity.

By taking advantage of the LMT product set, our client was able to meet GDPR compliance regulations within 3 months from starting the project.




LMT has been designed to support a wide range of business requirements from a single unified data management platform, including:
