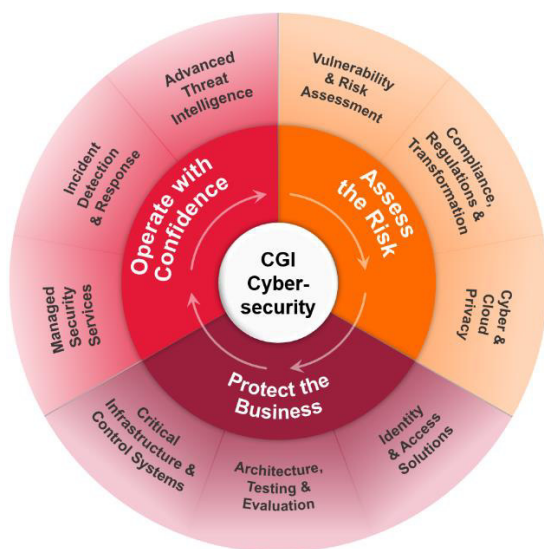
THE CHALLENGE

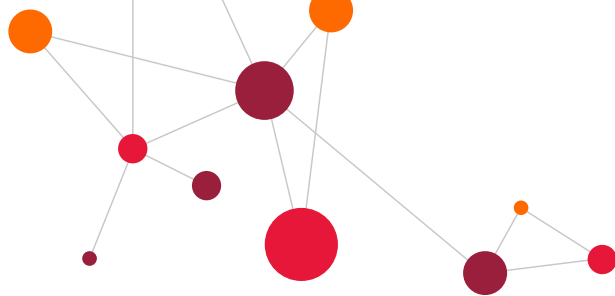
