The non-GAAP measures used in this presentation do not have any standardized meaning prescribed by IFRS and are therefore unlikely to be comparable to similar measures presented by other issuers. These measures should be considered as supplemental in nature and not as a substitute for the related financial information prepared in accordance with IFRS. Management believes these measures are useful to investors as it best reflects the performance of our activities and allows for better comparability from period to period as well as to trend analysis. The following non-GAAP financial performance measures are defined on pages 3, 4 and 5 of our quarterly MD&A which is posted on CGI’s website, and filed with SEDAR and EDGAR:






Adjusted EBIT and margin*




Cash provided by operating activities (in dollars and % of revenue)

Diluted EPS excluding specific items*












