### **CMS Websites**

The CMS websites consist of three interrelated portals—Medicare.gov, MyMedicare.gov and CMS.gov—that serve the growing millions of beneficiaries of Medicare and Medicaid. With CGI's help, CMS has achieved greater than 450% increase in MyMedicare account registrations this year during Open Enrollment compared to last period.

### **CMS CPI API Gateway**

The API Gateway project improves data collection and sharing across CPI's systems and stakeholders by strengthening program integrity and responsible stewardship by reducing improper payments, fighting fraud, and integrating financial, performance, and risk management.

### **CMS HPMS**

The Health Plan Management System is a Web-enabled data repository that helps to manage, monitor and track annual lifecycle activities for the submission, vetting and execution of Medicare Advantage Part C and Part D programs. The Bid Pricing Tool's (BPT) data unload processing was improved 30-fold, and automated image comparisons were implemented for testing data validations. CGI also conducted a CMMI Causal Analysis and Resolution (CAR) which reduced post-production defects by 49% across HPMS.

### **CMS MAPD**

The Medicare Advantage Prescription Drug program functions as the information and functionality foundation for Medicare Advantage Part C and Part D, and acts as the official enrollment platform between plan providers and CMS. CGI supported O&M optimization efforts to decrease staffing requirements by 63% while achieving all SLAs.



### **CMS MAS**

The Medicare Appeals System provides workflow management, document management and business intelligence capabilities to those responsible for filing and adjudicating all Medicare claims under Level 1, 2 and 3 appeals. CGI reduced performance tickets by 66% over a 6-month period by proactively monitoring and improving MAS performance, as well as deployed 12 releases over a 30-month period with zero configuration management issues.

# **CMS Open Payments**

The Open Payments system provides agnostic, accurate and timely information about payments or other transfers of value that occur between Medicare plan providers and pharmaceutical, biologic and medical device manufacturers. With CGI's help, CMS published 12 million payment records, transfers of value, or instances of ownership/investment interest—totaling \$8.2 billion in 2017. This represents a 166.7% increase in the total number of records published, and a 100% increase in the total value of payments over just a 4-year period, thereby significantly increasing transparency and accountability.

### **CMS PECOS**

Medicare's Provider Enrollment, Chain and Ownership System is a front-end, mission-critical enrollment application that serves as the national database of record for every Medicare provider in the U.S. Through automation of a self-service function, CGI reduced the number of manual NSC Global Load Requests from 210 (over the last 2 years) to fewer than five. Since its inception in 1998, CMS and CGI have grown PECOS from a paper-based system to processing over 2.6 million Medicare provider/supplier web-based enrollments. CGI is currently the lead PECOS 2.0 systems integrator for IT modernization efforts intended to redesign the current Medicare Enrollment System.

### **CMS PS&R STAR**

The Provider Statistical and Reimbursement System and the System for Tracking Audit and Reimbursement act as the hub for all finalized Medicare Part A claims and the Medicare Cost Report, along with its review, audit and settlement processes. CGI helped incorporate design efficiencies and a web front end into PS&R to optimize the multi-terabyte system to generate 96% of system reports in less than a minute.

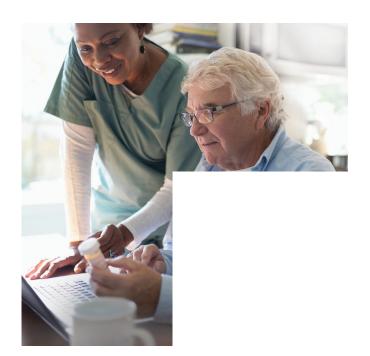

We helped evolve these early programs—from numerous IT system enhancements to data centralization to business processes transformation and cloud migration. Our joint success with these programs led to a long standing partnership.
