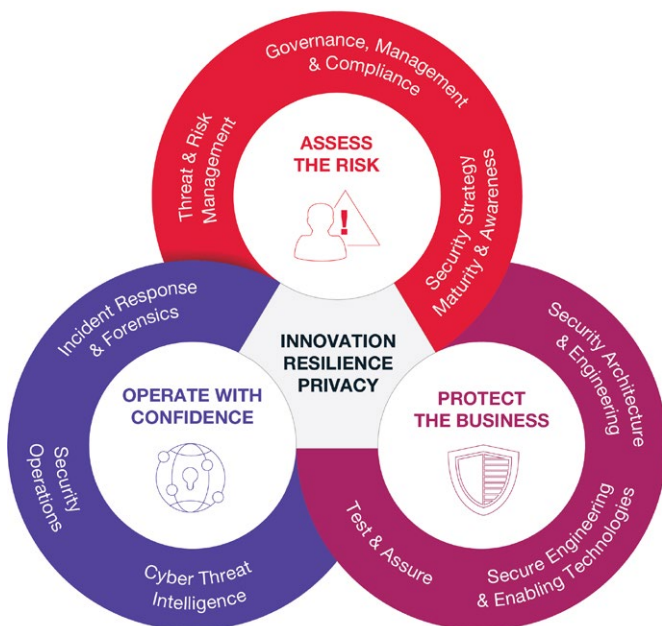

## Ensuring compliance

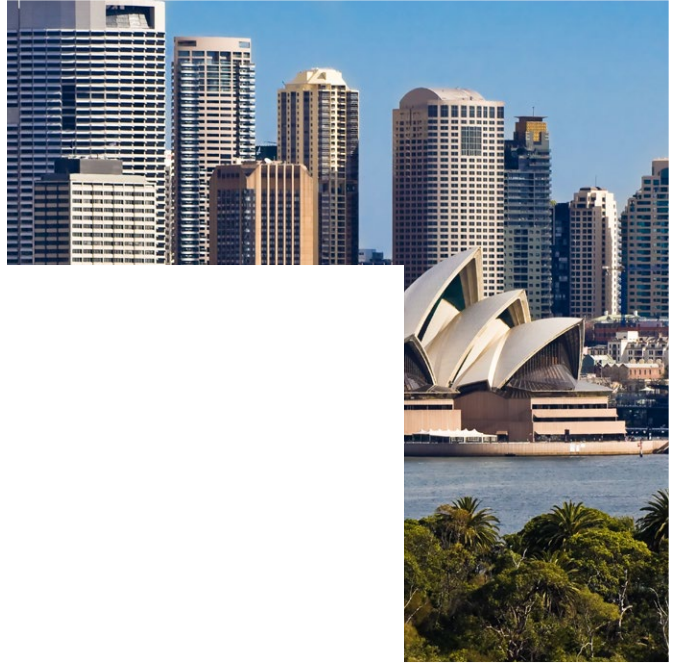
